The e-invoicing system was implemented on 1st August 2024 for companies with annual turnover of RM 100 million and thereafter will be fully implemented by 1st July 2025. The Inland Revenue Board of Malaysia (IRB) has issued several e-Invoice guidelines that contains clarifications and instructions on the e-invoicing mandate.
